individuals and the broader queer community in Nigeria. With a background in social justice and activism, Matthew has been at the forefront of important initiatives aimed at creating a more inclusive and accepting society for all individuals, regardless of their sexual orientation or gender

identity. They have been instrumental in creating safe spaces, both in-person and online, to provide support for LGBTQI+ individuals.

In recognition of their outstanding contributions to the LGBTQ+ community, Matthew has garnered several awards and accolades. As the Founder and Executive Director of Obodo, a youth-led organization with a focus on amplifying the voices and experiences of queer Nigerians, Matthew has spearheaded initiatives aimed at advancing queer education and rights in Nigeria through innovative mediums like art and technology to drive progress.

Dr. Stella Nyanzi

Dr. Stella Nyanzi is a Ugandan medical anthropologist with a PhD on youth sexualities from the London School of Hygiene and Tropical Medicine, Master of Science from University College London and a Bachelor of Arts degree in Mass Communication from Makerere University Kampala. She has 25 years of academic research in sexual subcultures relevant to HIV/AIDS, African Feminism, critical

masculinities studies, queer African studies, and dissidence studies. She is a prolific producer of scholarly academic knowledge about Uganda and The Gambia, available here. She is also a dissident poet, social justice activist for women's rights, LGBTIQA+ rights, free expression, academic freedom, digital democracy, and civil and political rights of opposition political parties in autocratic dictatorships. Currently, she is a scholarship-holder of the Writers-in-Exile program of PEN Zentrum Deutschland and lives in Germany with her three teenage children.

Maria Sjödin (Executive Director – Outright International)



Prior to becoming Executive Director, Maria served as Outright's Deputy Executive Director, leading the work of the development and communications teams. They also launched groundbreaking initiatives, such as Outright's COVID-19 Global LGBTIQ Emergency Fund and pioneering engagement with international businesses.

Maria previously served as Executive Director of RFSL, Sweden's largest LGBTIQ organization. While in this position, Maria established RFSL's international program, played a key role in ensuring that the human rights of LGBTIQ people become ingrained in the Swedish government's agenda for development and foreign affairs, advocated for marriage equality (achieved in 2009) and the abolishment of forced sterilization of trans people as a requirement for legal gender recognition (outlawed in 2013).

His work at the Asociación Corazón Diverso is characterized by the promotion of grassroots work. The organization is in constant communication with institutions and contributes to the social, economic and political empowerment of LGBTI people.

As part of his career as an activist and defender of the rights of the LGBTI population, he is currently active as a gay men's advisor for Bogotá's LGBTI public policy, and is part of the Bogotá LGBTI Working Group, which he coordinated for five years. He is also responsible for organizing the Pride event in Bogotá, currently considered the largest social mobilization in the country, and organizes the annual León Zuleta Awards, a national award for individuals and companies committed to LGBTI rights without being part of the community themselves.

He is a founding member of Pen Berlin, an organization committed to supporting writers in danger. He recently completed his master's degree in social work and human rights with focus on Forced Anal Examination as a form of Torture and Forced Migration. Fleeing his home country in 2018, Edward sought

asylum in Germany due to the threat of persecution based on his activism and sexuality. Today as the LGBTIQ community in Uganda is faced with the life-threatening Anti-Homosexuality Law, Edward and his Organization LWU are among the petitioners who are challenging the Law in the constitutional court of Uganda and calling for its repeal.

Edward believes that international pressure and the petitioning of the constitutional court are among the keyways to have the Law repealed, hence calling for everyone's solidarity and support.
